DENR SPECIAL ORDER NO. 2000-12

SUBJECT: PROVINCIAL MINING REGULATORY BOARD
(PMRB) OF QUEZON PROVINCE

In consideration to the indorsement of Governor Wilfrido L. Enverga dated 09 July 1999 and 28 July 1999 nominating Mr. Marciano Reyes Brion III, Vice President of Rotary Club of Lucena city, as the official Non-Government Organization representative to the PMRB, and Mr. Ramon O. Buhay, incumbent President of Small-Scale Miner's Association, as the official Small-Scale Mining Sector representative to the Board; and upon assumption of its chairmanship by the MGB-IV Regional Director, the Provincial Mining Regulatory Board of Quezon is hereby reorganized in accordance with the pertinent provision of R.A. 7942, otherwise known as the Philippine Mining Act of 1995, and its revised implementing rules and regulations to be composed of the following:

In the performance of its duties and functions, the Board shall be guided by the provisions of R. A. 7076 otherwise known as the "People's Small Scale Mining Act of 1991". Section 17 (B) (iii) and 138 of 7160 otherwise known as the "Local Government Code of 1991", R. A. 7942 otherwise known as the Philippine Mining Act of 1995" and its revised implementing rules and regulations, P. D. 1899 (Establishing Small Scale Mining Act of New Dimension in Mineral Development); DENR Administrative Order Nos. 30, 34 and 37, series of 1992; DENR Memorandum Circular No. 10, Series of 1992; Malacañang Memorandum Circular No. 30 dated 09 February 1991 "Prescribing Guidelines for the Implementation of 1991 Local Code (R. A. 7160)" and other laws, rules and regulations governing the administration and disposition of mineral resources.

This Order shall take effect immediately and shall remain in force unless revoked in writing by the undersigned or any other competent authority.
