SPECIAL ORDER NO. 2000 - 181

SUBJECT: CREATION OF PROVINCIAL MINING

REGULATORY BOARD (PMRB) FOR THE PROVINCE OF MISAMIS ORIENTAL, PURSUANT TO R.A. NO. 7076, R.A. 7942 AND THEIR IMPLEMENTING RULES AND

REGULATIONS.

Pursuant to the pertinent provisions of R.A. No. 7076, the "People's Small Scale Mining Act of 1991", and R.A. No. 7942, the "Philippine Mining Act of 1995", the Provincial Mining Regulatory Board (PMRB) for the Province of Misamis Oriental is hereby organized to be composed of the following:

In the performance of its duties and functions, the board shall be guided by the applicable provisions of DENR Administrative Order No. 96-40, Series of 1996, amending DENR Administrative Order No. 95-23, Series of 1995, the Implementing Rules and Regulations of R.A. No. 7942; DENR Administrative Order No. 34, Series of 1992, the Implementing Rules and Regulations of R.A. No. 7076 and other laws, rules and regulations and circulars governing the administration and disposition of mineral resources.

Further, to ensure the continuity of its operation in case of resignation, retirement, reassignment or leave of absence of the Chairman, the Vice-Chairman shall automatically assume the Chairmanship of the Board and shall preside over the Official functions attendant thereto until such time that a new Chairman is designated by the Secretary.

Provided finally, that any other substitution of membership in the Board contrary to the herein provisions shall be considered a reorganization of the said Board and shall necessarily require an amendment of this Order.

This Order shall take effect immediately and shall remain in force unless

revoked in writing by the undersigned.
