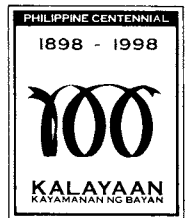


The registration expenses of Central Office and PAWB personnel shall be charged against Special Projects Funds (II.g) while their traveling expenses shall be charged against their respective offices.
