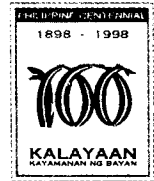


Herein designates shall perform their functions in addition to their present work load. The Sub-Committees shall:

1. Spearhead the implementation of the programs/projects/activities within their respective areas of jurisdiction, in cooperation with appropriate persons, agencies and organizations;
2. Submit progress reports (following completed staff work standards) to the Chairperson of the PCICDSCS attention the Executive Office; and
3. Perform other related tasks as may be assigned by the Chairperson of the PCICDSCS-TWG.

In order to facilitate the smooth implementation and coordination of the Commission's mandates, *Undersecretary Mario S. Roño*, International Commitment and Local Government Affairs (ICLGA) and *Director Medel P. Lim Suan* of the Directorate for Special Project on Water and Integrated Ecosystems Management and Development (DSPWIEMD) both of DENR, are hereby designated as *Vice-Chairman and Executive Officer of PCICDSCS*, respectively.

Expenses to be incurred by the Sub-Committees shall be funded by the Sulu and Celebes Seas Fund, subject to the procedures set forth and pertinent accounting and auditing rules and regulations.

This order shall take effect immediately and supersedes all orders or instructions inconsistent herewith.
