COMMITTEE TO **FORMULATE** CREATION OF Α APPROPRIATE STRATEGY IN THE IMPLEMENTATION OF THE CONCEPT OF SUSTAINABLE FOREST MANAGEMENT TO THE OPERATION OF COMMUNITY FOREST MANAGEMENT **AWARDED** AGREEMENT No. 13-001 TO SAMMILLIA LOCATED AT THE MUNICIPALITIES OF SAN AGUSTIN, SAN MIGUEL. MARIHATAG AND LIANGA, SURIGAO DEL SUR.

In the interest of the service and in order to come up with appropriate strategies in the employment of the concept of sustainable forest management to the operation of CFMA No. 13-001 awarded to SAMMILLIA, a committee is hereby created to be composed of the following;

The committee is tasked to accomplish the following:

- a. Review the existing policies in the implementation of the Community Forest Management Agreement under the sustainable forest management concept;
- b. Identify and lay-out strategies by which sustainable forest management shall be employed in the operation of CFMA No. 13-001 awarded to SAMMILLIA;
- c. Review the present organizational structure/set-up and by laws of the Federation;
- d. To look into a management scheme by which NRDC and other investors would be able to venture into the concept of sustainable forest management;
- e. To assist in the revision of the comprehensive management plan for the CFMA area;

The committee shall periodically meet to discuss policy strategies on sustainable forest management upon the approval of this order;

The committee is authorized to seek the assistance of all government agencies and instrumentalities in the carrying-out of the assigned task;

They shall submit a report with complete documentation to the UNDERSIGNED on updates of their periodic meeting including its recommendation.

All expenses to be incurred shall be chargeable to the NRDC funds subject however to the usual accounting and auditing rules and regulations.

This Order takes effect immediately.
