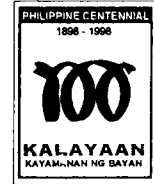

The Committee shall prepare a budget proposal for this sport activity and shall be accountable in its liquidation at the close of the tournament, review the accounting of expenses incurred.

Lawn Tennis (M & W)	-	Environmental Management Bureau
Chess (M & W)	-	Forest Management Bureau
Darts (Men & W)	-	Mines and Geo-Sciences Bureau
Practical Shooting	-	Office of the Secretary

Each Sub-Committee is authorized to identify three (3) members to assist them in the conduct of the games. They shall spearhead and oversee the implementation of each event.

All DENR officials and employees shall extend all possible assistance to both Committees whenever necessary and they shall be authorized on official time to watch and participate in any or all of the events.

The DENR Summer Inter-Bureau Sports Tournament 2000 shall be for the period from May - June 2000 and all expenses to be incurred on this regard shall be charged to respective Agency funds.
