DENR officials and consultants from the Central Office and Bureaus as well as appropriate Civil Service Commission (CSC), Department of Foreign Affairs (DFA) and Philippine Information Agency (PIA) officials shall act as resource persons.

The budget required to implement the activity shall be sourced from available funds from the Central Office which shall include food and accommodation of participants, resource persons and training staff; supplies and materials; and honoraria for the resource persons. The travelling and transportation expenses including per diems shall be charged against the funds of the respective mother units of the participants, DENR resource persons and training staff. CSC, DFA and PIA personnel who shall act as resource persons shall charge their travelling and transportation expenses against DENR Central Office funds. These expenses are subject to the usual accounting and auditing rules and regulations.

This Order takes effect immediately and shall remain in force until the completion of the activity.
