AUTHORITY TO GRANT HONORARIA FOR THE NATURAL RESOURCES MANAGEMENT PROGRAM

(NRMP) FOR CY 2000

In the interest of the service and in accordance with the Approved Work and Financial Plan for CY 2000, NRMP shall provide honorarium to officials and personnel concerned on the different DENR offices. Personnel from these offices who have rendered services in addition to their regular duties in the implementation of the project as listed in "Annex A" hereof are hereby authorized to receive corresponding honorarium effective January 1 to December 31, 2000. As such, the honorarium to be paid to each personnel shall conform with the provisions of DBM NCC No. 75, S 1995. Funds for this purpose shall be charged against NRMP, subject to the usual accounting and auditing rules and regulations.
