SUBJECT:

The regional representatives shall automatically compose the Regional Training Management Team in their respective regions. They shall prepare and implement an action plan relative to the conduct of CBFM training programs among DENR Staffs in the Regional Offices, PENROs and CENROs, LGU counterparts, and Peoples' Organizations within the region.

Expenses for food and accommodation and other expenses that will be incurred in the conduct of the training course shall be charged against the Agrarian Reform Fund for CBFM-CARP in the amount of P360,000. The amount of P160,000 shall be charged against the training funds of DENR-HRMS.

Traveling expenses and transportation allowances of the training participants and Management Team (Regional and Central Office participants) shall be charged against the budget of their respective offices.

The Training Management Team shall submit a report to the Secretary through the Director, HRMS within one (1) month after the implementation of the training.

This Order shall take effect immediately.
