Each region is required to bring the following equipment: 1) Total Station with accessories, 2) GPS units' 3) at least one (1) pair of hand held radios, and 4) transit which will be used during the practicum.

Traveling expenses of participants from Regions 5, 7, 8 and CARAGA shall be charged to the CBRM funds in their regions while that of the resource persons and training staff shall be charged to the DENR CBRM Project Funds at the Central Office.

Food and accommodation of resource persons and participants from Regions 5, 7, 8, and CARAGA; and other training-related incidental expenses shall also be charged to the CBRM Central Office Funds..

Traveling and other training related expenses to be incurred by participants from Region 6 shall be charged to the DENR Banner Program funds in their region.

All allowable expenses are subject to the usual accounting and auditing rules and regulations.
