As such, the PSU shall perform the following functions and responsibilities:

- 1. Provide advisory, technical and administrative support to the Project as necessary
- 2. Formulate the terms of reference of the consultant for DENR
- 3. Review and approve outputs of the DENR consultant/s and make appropriate endorsements/recommendations to the NEDA-PMU in accordance with the approve WFP of DENR

- 4. Formulate the WFP of the DENR for incorporation to the consolidated WFP
- 5. Organize and conduct meetings, workshops and relevant training pertaining to the Project
- 6. Assist the NEDA-PMU in the progress monitoring, evaluation and reporting of the Project's implementation
- 7. Ensure the institutionalization of the PPMIS capacity building skills gained from the Project

All expenses incurred by the PSU in the discharged of the their functions shall be charged against the Project budget and the partner agency's budget, in particular, budget under Support to Operations, II.a, Coordination, formulation and integration of ENR sector plans and policies and II.b, Coordination. Monitoring and evaluation of ENR programs and projects including those devolved to LGUs. In addition, the PSU is hereby authorized to provide the 10% counterpart fund for the procurement of hardware/software for the project.

The PSU is also authorized to call on other DENR units or personnel to ensure smooth project implementation.

This Order takes effect immediately and shall remain in force unless otherwise revoked in writing.
