SUBJECT

AUTHORIZING THE CONDUCT OF A WORKSHOP ON THE ACCELERATION OF THE ACTIVITIES OF THE DEPARTMENT AND REGIONAL TASK FORCES ON FORESHORE AREAS AND SPECIAL LAND USES TO BE HELD ON AUGUST 15-17, 2001 AT THE MANILA MANOR HOTEL, MALATE, MANILA.

In the interest of the service and in order to realize the objectives and effectively monitor the implementation of activities of the Department and Regional Task Forces on Foreshore Areas and Special Land Uses (TFFASLU) pursuant to DENR Special Order No. 99-58 dated January 21, 1999 and No. 99-849 dated July 28, 1999 respectively, the conduct of a workshop is hereby authorized which will be held at the Manila Manor Hotel, Malate, Manila on August 15-17, 2001. A report on the workshop proceedings shall be submitted by LMB to the Office of the Secretary through the Undersecretary for ENR Legal, Lands and International Affairs within fifteen (15) days after completion of the workshop.
