The Teams shall report to the Management and Performance Audit Committee for coordination and instructions relative to their assigned task and activities.

All concerned sectors and units of the Department are enjoined to extend full support and assistance to the Teams to ensure the expeditious accomplishment of their task.

The Team shall conduct the management and performance audit within two (2) weeks and submit to the undersigned the findings and recommendations within five (5) days upon completion of the investigation.

A Monitoring Team is also created to supervise and monitor the activities of the management and performance audit teams, to be composed of the following DENR Officials, to wit:

The Teams are authorized to conduct a post evaluation workshop in order to assess the results of the financial management and performance audit.
