Subject: CREATION OF A SPECIAL BOARD OF INQUIRY TO INVESTIGATE THE COMPLAINT AND REQUEST FOR REINVESTIGATION OF ONE WILSON A. NG AGAINST GREGORIO NESPEROS, REGIONAL EXECUTIVE DIRECTOR, REGION 3, SAN FERNANDO PAMPANGA AND OTHER DENR OFFICIALS, WHICH SHALL REPORT THE RESULTS THEREOF AND RECOMMEND APPROPRIATE ACTION/S TO THE SECRETARY

In the interest of the service and relative to the Sworn Complaint and Request For Reinvestigation of one Wilson A. Ng dated October 11, 2001 against several Department of Environment and Natural Resources Officials for allegedly participating in obtaining an illegal Search Warrant, committing serious irregularities in the implementation of said Search Warrant and unlawfully confiscating Narra and Almaciga lumber which were lawfully secured, a Special Board of Inquiry is hereby created to investigate the said matter, report the results thereof and recommend the appropriate action/s to the Secretary.

The Board shall be composed of the following:

Atty. MICHELLE ANGELICA D. GO from the Office of the Secretary as Chairperson;
Atty. DANIEL M. NICER from the Office of the Undersecretary for Lands, Legal and International Affairs as Member; and
Atty. SANTIAGO F. RODRIGUEZ, Director, Legal Services as Member

The Board is hereby directed to conduct its investigation on Gregorio Nesperos, Regional Executive Director, Region 3, San Fernando, Pampanga; Romeo Buenaventura, Provincial Environment and Natural Resources Officer, Malolos, Bulacan; Rolando Suetos, Community Environment and Natural Resources Officer, Tabang, Bulacan; and Rommel Baldemoro, DENR Bulacan, based on the aforementioned Complaint and Request for Reinvestigation, within FIFTEEN (15) days from the effectivity of this Order with full authority to issue notices, subpoena ad testificandum and duces tecum and to perform such other acts which may be necessary to carry out its mandate under this Order. It shall submit its report and recommendation to the undersigned not later than TEN (10) days from the termination of its proceedings.

This Order shall take effect immediately.
