**SUBJECT: Authorizing the conduct of the Fifth DENR National Gender and Development (GAD) Congress on December 3-5, 2001 at Hotel Supreme, Baguio City**

To assess the extent of the commitments made during the Cebu Congress and in order to chart the directions of DENR towards GAD mainstreaming, the conduct of the Fifth DENR National Gender and Development (GAD) Congress to be held on December 3-5, 2001 at Hotel Supreme is hereby authorized.

Selected DENR personnel and members of the GAD Focal Point System from the central office, bureaus, field offices (regional, DENR and CENR offices) and attached agencies, as per attached official list, are authorized to participate in the Congress.

Training expenses of OSEC- central office participants, bureaus (2 reps), regional offices (2 reps) and attached agencies (2 reps) shall be charged to central office GAD funds while transportation expenses shall be shouldered by respective offices subject to the usual accounting and auditing rules and regulations.

Other participants who will join the Congress must pay for their transportation, board and lodging charged to their respective GAD funds.
