SUBJECT : AUTHORIZING DENR PERSONNEL TO RECEIVE HONORARIUM IN RELATION TO THE IMPLEMENTATION OF THE PARTNERSHIP IN ENVIRONMENTAL MANAGEMENT FOR THE SEAS OF EAST ASIA-PHILIPPINES (PEMSEA-PHILS.)

In the interest of the service and in accordance with the project's approved Work and Financial Plan for CY 2001, the Partnership in Environmental Management for the Seas of East Asia -Philippines (PEMSEA-Phils.) shall provide honorarium to officials and personnel under the different DENR offices and other agencies involved in implementation of the project.

Personnel from these offices who rendered services in addition to their regular duties in the implementation of the Project as listed in Annex A hereof are hereby authorized to receive corresponding honorarium effective January-December, 2001, payable before the end of the year 2001.
