**SUBJECT : AUTHORIZING PERSONNEL FROM DENR AND OTHER GOVERNMENT AGENCIES TO RECEIVE HONORARIUM IN RELATION TO THE IMPLEMENTATION OF THE PHILIPPINE OZONE DESK.**

In the interest of the service and in accordance with the approved Work and Financial Plan for CY 2001, the Philippine Ozone Desk shall provide honorarium to officials and personnel under the different DENR offices and other government agencies involved in the implementation of the project.

Personnel from these offices who rendered services in addition to their regular duties in the implementation of the Project as listed in Annex A hereof are hereby authorized to receive corresponding honorarium effective March – December, 2001 payable before the end of the year 2001.

As such, the honorarium to be paid to each personnel shall conform with the provisions of DBM NCC No. 75, S. of 1995, prescribing the guidelines and procedures for the grant of honoraria to government officials and employees. Funds for this purpose shall be charged against the Philippine Ozone Desk (Interest Earnings) funds subject to the usual accounting and auditing rules and procedures.
