To foster cost efficiency and to facilitate the conduct of the activity, the workshop venue shall be held on a by island grouping following the schedule below:

- 2. Mindanao Group (Regions 9,10,11,12,13 and ARMM)
  January 18-19 at Davao City
- 3. Visayas Group (Regions 6,7, and 8) January 25-26 at Tacloban City

Likewise, all Deputy Heads of Regional DENR-CARP Secretariat are directed to report to the Central Office on January 8, 2002 for the orientation on the mechanics of the workshop and the planning and budgeting guidelines for CY 2002.

All workshop-related and traveling expenses of the Central Office participants shall be charged against CARP-OSEC allocation under the Agrarian Reform Fund (ARF) 158. To partly defray workshop expenses, all regional/field participants shall be charged of PhP2,500.00 each as registration fee. All checks should be issued to DENR Thrust, DENR Region XI and DENR Region VIII for Luzon, Mindanao and Visayas group, respectively to be acknowledged by an official receipt. Traveling expenses of the regional participants shall be charged against ARF appropriations of their respective offices, subject to the usual accounting and auditing rules and regulations.
