**SUBJECT : AUTHORIZING PERSONNEL FROM DENR
AND OTHER GOVERNMENT AGENCIES TO
RECEIVE HONORARIUM IN RELATION TO
THE IMPLEMENTATION OF THE
PHILIPPINE OZONE DESK.**

In the interest of the service and in accordance with the approved Work and Financial Plan for CY 2002, the Philippine Ozone Desk shall provide honorarium to officials and personnel under the different DENR offices and other government agencies involved in the implementation of the project.

Personnel from these offices who rendered services in addition to their regular duties in the implementation of the Project as listed in Annex A hereof are hereby authorized to receive corresponding honorarium effective July – December 2002 payable before the end of December, 2002.

As such, the honorarium to be paid to each personnel shall conform with the provisions of DBM NCC No. 75, S. of 1995, prescribing the guidelines and procedures for the grant of honoraria to government officials and employees. Funds for this purpose shall be charged against the Philippine Ozone Desk (Interest Earnings) funds subject to the usual accounting and auditing rules and regulations.

This Order shall take effect immediately.
