The DENR-TExTT shall:

- a. Provide technical assistance in the delivery of sustainable NRM technologies in the upland and coastal municipalities of LGUs with on-going subprojects;
- b. Act as technical service provider in the regions/LGUs needing immediate and specific technical expertise in project development, training and extension; and
- c. Provide recommendations to enhance/improve LGUs' project implementation.

The services of the members of the abovementioned experts' pool will be on-call basis depending on the need of the LGUs on their respective field of expertise.

The DENR-TExT Team members shall be entitled to claim travelling expenses, allowances, incentives and/or remuneration in the conduct and performance of duties chargeable against the respective CBRMP-ETT funds subject to the usual government accounting and auditing procedures.

This Order shall take effect immediately and in force until the completion of the project.
