3. The Project Team shall oversee the development and implementation of the project. It shall have the following functions:

- a. Serve as counterpart to the advisory/consultancy Project Team of the Asian Institute of Journalism and Communication (AIJC);
- b. Provide technical and administrative support requirements for the project and the AIJC Project Team;
- c. Mobilize the participation of all concerned DENR offices and personnel in the project and coordinate such participation through conferences, seminars, group meetings, and individual involvement;
- d. Facilitate access to DENR information needed by the AIJC Project Team;
- e. Generate internal inputs/perspectives for the development of the project framework, methodologies, and strategies and share them with the AIJC Project Team;
- f. Participate in planning and strategy formulation activities;
- g. Provide linkage between the AIJC Project Team and appropriate DENR officials, services/units, and other external consultants.

4. The Chair is authorized to call meetings, conduct workshops, and require DENR IEC central and regional office focal persons to provide information relevant to the development and implementation of the project and to ask their participation in project activities.
5. The DENR Project Team shall submit periodic reports to the undersigned on the progress of the project.
6. Expenses incidental to the performance of the functions of the DENR Project Team shall be charged to the DENR's Regular and Special Funds and other funds that may be designated by the Secretary for this purpose.
7. This Order takes effect immediately and supersedes all orders, memoranda, or instructions inconsistent herewith.
