The above-named employees shall clear themselves of all accountabilities from their present work assignments and shall sign a Local Scholarship and Service Obligation Contract within thirty (30) days after enrollment for their first semester. The Chair, Scholarship Committee is hereby authorized to sign their Scholarship and Service Obligation Contracts. The contract shall serve as the basis for evaluation of performance as regards compliance with scholarship rules and regulations.

This Order is in effect for the duration of the scholarship grant only.
