**SUBJECT: CREATION OF CENTRAL PROJECT MANAGEMENT OFFICE
AND REGIONAL SUB-PROJECT MANAGEMENT OFFICES IN
REGIONS 7 AND 13 FOR THE SOUTHERN PHILIPPINES
IRRIGATION SECTOR PROJECT-WATERSHED MANAGEMENT
SUB-COMPONENT (SPISP-WMC)**

1. In the interest of the service and pursuant to the Memorandum of Agreement entered with the National Irrigation Administration (NIA) regarding the implementation of the Watershed Management Sub-component of the Southern Philippines Irrigation Sector Project (SPISP), a DENR Central Project Management Office (CPMO) is hereby created in the Forest Management Bureau, and Sub-project Management Offices (SPMO) are hereby created in Regions 7, 13 and other Regions as may be later identified.

Central Project Management Office (CPMO)

The CPMO shall initially be composed of the following:

The Project Director who shall hereby report to the Secretary through the designated DENR Project Implementation Officer (PIO), shall recommend personnel to act as Administrative Operations Specialist, and other project support staff/counterparts at the CPMO.

Regional Sub-project Management Offices (SPMO)

At the Regional Level, Sub-project Management Offices are hereby created initially for the Regions 7 and 13. Creation of the other SPMOs shall be formalized thru similar Special Order.

2. In addition to coordination, the DENR Central Project Management Office shall evaluate and monitor the progress of field project implementation, maintain linkage with NIA-Central Office SPISP-PMO; coordinate and package the yearly program of work and financial plan of the Watershed Management Sub-component, which will be submitted to NIA-SPISP-CPMO and serve as basis for annual budget releases to the project.
3. The SPMOs shall be responsible for the formulation of their respective yearly program of work and financial plan and submit to CPMO for consolidation/packaging, prior to submission to NIA-CPMO-SPISP; responsible for the day to day activities in project implementation, and submit progress report and statement of expenditures to CPMO, NIA-CPMO-SPISP and Regional Offices concerned for monitoring and evaluation purposes.
4. The Project Director shall be entitled to representation and transportation allowance, (RATA), honorarium, and all expenses to be incurred in the exercise of his function as CPMO Director, while the above-cited staff shall be entitled to honorarium, travelling allowances and other incidental expenses.
5. All expenses incurred by the Central Project Management Office and Regional Sub-Project Management Offices in the performance of their tasks/responsibilities shall be chargeable against project funds, subject to existing accounting and auditing rules and regulations.

6. The CPMO and SPMO are hereby authorized to call on any DENR Office in the pursuit of the project objectives and mandates.

7. This Order takes effect immediately and supersedes other orders inconsistent herewith.
