- c) significant results for policy formulation and development planning of the Department;
- d) new researchable areas; and
- e) problems encountered during the implementation and recommend specific courses of action

A Secretariat shall be formed in every region and shall be chaired by the ERDB Planning Staff, who shall prepare all necessary documents needed for the review. They shall be responsible for the consolidation of all evaluation reports and the preparation of the Summary Output per region.

All expenses to be incurred in the conduct of the said Review shall be charged against the respective offices subject to the accounting and auditing rules and regulation.

Summary reports of the evaluation including the recommendations shall be submitted to this Office not later than 30 days after the last evaluation shall have been completed.
