**SUBJECT : AUTHORIZING THE CONDUCT OF THE  
PHILIPPINE SUSTAINABLE MOUNTAIN  
DEVELOPMENT SUMMIT**

In the interest of the service and in line with the celebration of the International Year of Mountains, the conduct of the Philippine Sustainable Mountain Development (SMD) Summit to be held in Los Baños, Laguna on June 27-28, 2002 is hereby authorized. The Summit shall prepare the working documents for the Philippine Mountain Agenda to be presented in Johannesburg Rio +10 Conference in October, 2002.

Participants to the Summit shall be representatives from the various agencies and institutions involved in the implementation of the Chapter 13 regarding Sustainable Mountain Development of Agenda 21 that includes the following:

The National Organizing Committee for the International Year of Mountains (NOC-IYM) created per Special Order No. 2002-106 shall be responsible for the conduct of the Summit and the development of the Philippine Mountain Agenda.
