

Training expenses such as food and accommodation of the participants, resource persons and training staff, honorarium of the resource persons, supplies and materials, bus rentals, transportation and traveling expenses of non-DENR resource persons and the training staff shall be charged against the allotment of the MDD, HRMS.

This Order takes effect immediately and shall remain in force until the completion of the activity.
