- The RFITs shall undertake forest resources assessment in their respective 3. regions using the inventory design developed for the project.
- The RFITs are authorized to seek the assistance of any official/personnel 4. in the concerned Regional Environment and Natural Resources Offices (RENROs), Provincial Environment and Natural Resources Offices (PENROs) and Community Environment and Natural Resources Offices (CENROs).
- 5. The RFITs shall seek the assistance of PAWB/EMPAS personnel when a field observation site fall within protected areas. The PAWB/EMPAS personnel shall assist the RFITs at sites falling inside protected areas, following their mandate for community interaction in these areas.
- The RFITs shall be entitled to reasonable transportation expenses, 6. allowances and per diems chargeable against the FRA Funds subject to the usual accounting and auditing rules and regulations.
- The RFIT may be assisted by Forest Management Bureau Field Inventory 7. Assistance Team (FMB-FIAT) to be designated by the Director, FMB when the FRA National Coordinating Office (FRA-NCCO) determines that there is a need to facilitate the speedy completion of the task. The members of the FMB-FIAT shall be entitled to the same privileges and remuneration as the RFIT.

The membership of the FRA-NCO created under FMB Special Order No. 2002-57 dated May 14, 2002 is hereby augmented to include representatives from the National Mapping and Resource Information Authority (NAMRIA), as follows:

The NAMRIA representatives shall, through their Remote Sensing and Resource Data Analysis Department, provide spatial information required for the design and implementation of the assessment. They shall also provide training on GPS and field measurement techniques.

This Order takes effect immediately and supercedes other Orders 10 inconsistent herewith.
