**SUBJECT: AUTHORIZING DENR PERSONNEL TO RECEIVE
HONORARIUM IN RELATION TO THE PHILIPPINES' CO-
HOSTING OF THE INTERNATIONAL CORAL REEF INITIATIVE
(ICRI) SECRETARIAT**

In the interest of the service and in accordance with the Project's approved Work and Financial Plan for CY 2002, the International Coral Reef Initiative (ICRI) Secretariat shall provide honorarium to officials and personnel under the different DENR offices and other agencies involved in the co-hosting of the ICRI Secretariat.

Personnel from these offices who rendered services in addition to their regular duties in the implementation of the activities of the Secretariat as listed in Annex A hereof are hereby authorized to receive corresponding honorarium effective January 1 – December 31, 2002, payable on a semi-annual basis.

As such, the honorarium to be paid to each personnel shall conform with the provisions of DBM NCC No. 75, Series of 1995 which prescribes the guidelines and procedures for the grant of honoraria to government officials and employees. Funds for this purpose shall be charged against the ICRI-GOP counterpart funds, subject to existing accounting and auditing rules and procedures.

This Order shall take effect immediately.
