

All Bureau and Regional Youth Desk Officers shall undertake the implementation of the DENR Youth Program in their respective sector/areas. A quarterly accomplishment report shall be submitted to the Office of the Secretary through the Central Office Youth Desk.

Funds to be used for the implementation of the DENR Youth Program shall be sourced from respective bureau/regional offices.

This Order shall take effect immediately and supersedes all previous issuances inconsistent herewith.
