**SUBJECT: CREATION OF A PROJECT MANAGEMENT TEAM (PMT) TO IMPLEMENT THE ACTION PLAN AND PROJECT (APP) OF MR. REYNALDO F. MOLINA OF FASPO AS AN ACADEMIC REQUIREMENT OF THE DEVELOPMENT ACADEMY OF THE PHILIPPINES (DAP) MASTER IN PUBLIC MANAGEMENT (MPM) PROGRAM**

In the interest of the service and in connection with the agency-based implementation of the DAP-MPM Program Action Plan and Project (APP) of Mr. Reynaldo F. Molina of DENR-FASPO entitled "**Assessment of Key Factors Affecting DENR Foreign-Assisted Projects (FAPs) Absorption Capacity and Generation of Multistakeholder Agreements on Corresponding Solutions**", a Project Management Team (PMT) is hereby created to implement the project plan of the said APP for a period of two months starting September 9, 2002.

The assigned division representatives shall perform the various project-related tasks contained in the APP Project Plan. Specifically, they shall assist the Project Team Leader in implementing the following APP activities in addition to their respective regular functions:

1. Conduct actual individual interviews and focused group discussions (FGD) with the identified respondents;

2. Analysis, consolidation and integration of gathered data, findings and proposed recommendations;
3. Presentation and validation of findings and recommendations with the implementing offices; and
4. Solicit and document comments and suggestions on the findings and recommendations presented.

A Project Steering Committee (PSC) shall likewise be created to oversee and provide guidance and direction to the PMT in the implementation of the APP. The PSC shall be composed of the following directors and division chiefs of FASPO:
