SUBJECT: REORGANIZATION OF PAMPANGA PROVINCIAL MINING REGULATORY BOARD (PMRB) PROVIDED UNDER REPUBLIC ACT (R.A.) NO. 7076, REPUBLIC ACT (R.A.) NO. 7160, REPUBLIC ACT (R.A.) NO. 7942, DENR ADMINISTRATIVE ORDER NO. 96-40 SERIES OF 1996

Pursuant to the provisions of R.A. No. 7076 otherwise known as the "People's Small-Scale Mining Act of 1991, R.A. No. 7160 otherwise known as the "Local Government Act of 1991", and R.A. In the performance of its duties and functions, the Board shall be guided by the applicable provisions of DENR Administrative Order No. 96-40, Series of 1996, amending DENR Administrative Order No. 95-23, Series of 1995, the

Implementing Rules and Regulations of R.A. No. 7942; DENR Administrative Order No. 34, Series of 1992, the Implementing Rules and Regulations of R.A. No. 7076, R.A. No. 7160 and its Implementing Rules and Regulations and other Laws, Rules and Regulations and Circulars governing the administration and disposition of mineral resources.

In case where the PENRO of Pampanga as Chairman of the Board, has become ineffective or unable to discharge his functions as determined by the Regional Director, the latter has the authority to relieve the former after proper notification in writing, and thereafter, assume the Chairmanship or designate a new representative as Chairman.

Pursuant to DENR Memorandum Circular No. 97-05, the Chairman shall submit a quarterly report to the MGB Director, the DENR Regional Executive Director and the Secretary, containing the accomplishments, issues encountered and resolutions made and other relevant information.

This Order shall take effect immediately and shall remain in force unless

revoked in writing by the undersigned.
