CREATION OF INTER AGENCY TASK FORCE IN THE FORMULATION OF A COMPREHENSIVE LAND MANAGEMENT PLAN OF THE MUNICIPALITY OF CULION PER RA 9032

The Task Force shall undertake the following:

- 1. Resolve issues between and among agencies concerned regarding the determination of areas which shall remain with DOH, belong to the public domain and which shall become the property of the Municipality of Culion and the Province of Palawan.
- 2. Formulate guidelines and strategies in the conduct of land classification, surveys and the issuance of the corresponding patent to qualified claimants.
- 3. Formulate guidelines on existing contracts and special use permits issued prior to RA 9032.
- 4. Explore and determine environmental concerns affecting the formulation of the Culion Comprehensive Land and Water Use Plan.
- 5. Undertake related tasks as maybe determined by the task force.

The Task Force is authorized to create a Secretariat to be headed by the OIC-Regional Technical Director for Lands, MIMAROPA Region, to provide administrative support and other related functions to the Task Force.

All expenses that maybe incurred by the Task Force in relation to its functions shall be charged against the allotment of their respective offices, subject to the usual accounting and auditing rules and regulations.

This order takes effect immediately.
