The Teams shall undertake the following tasks:

1. Assess the physical accomplishments of the CBFMA holders vis-à-vis CRMF, AWP, and RUP.

2. Review and evaluate the procedures and processes adopted by the CENRO concerned in the affirmation of CRMFs, AWPs and in the issuance of Resource Use Permits (RUPs)

3. Assess and evaluate the technical, financial, economic, and institutional mechanisms in support of the activities of the CBFM;

4. Gather other relevant information following the Terms of References (TOR) herewith attached as Annex A;

5. Document the effectiveness/sustainability of the CBFM Strategy;

6. Recommend management interventions and policy measures to address identified issues and concerns; and

7. Submit report to the Coordinating Committee on or before 24 January 2003.

The Teams shall coordinate with the concerned Local Government Units (LGUs) and the Regional/Provincial Multi-Sectoral Forest Protection Committees (MFPCs) for assistance.

The Regional Executive Director shall provide the necessary transportation and logistical arrangements for the Team(s) assigned to their respective regions.

Traveling and other incidental expenses to be incurred during the conduct of this assessment shall be charged against the respective budget of the offices and/or organizations concerned subject to existing accounting and auditing rules and regulations.
