The Forestry Sector Meeting cum Assessment shall, among others, convene all the newly-designated Regional Technical Directors for Forestry (RTDs-F) for a sectoral meeting and enhance the capabilities of the Regional Field Inventory Teams (RFITs) in the collection of field data and improve the current data collection approach.
  3. The attendance/participation of the above-listed personnel shall be on official time.
  4. All expenses incidental to the implementation of the meeting shall be charged against the FMB-FRA funds subject to the usual accounting and auditing rules and regulations, except for travelling expenses of the RTDs for Forestry which shall be charged against the funds of their respective offices. The travelling expenses of all concerned shall be refunded at the workshop venue upon presentation of necessary documents.
  5. This Order takes effect immediately and shall remain in force on the date specified above.
