**DENR SPECIAL ORDER**

No. 2003 - 511

**SUBJECT : Creation of a Special Task Force for the Survey of Presidential Proclamations on Housing Projects within Metro Manila.**

In compliance with the instruction of the President to fast track the implementation of the proclamations, executive orders and other issuance covering areas within Metro Manila reserved for housing site purposes, a DENR Special Task Force is hereby created for the conduct of the perimeter survey of the reserved areas preliminary to the activities to be undertaken by the Housing and Urban Development Coordinating Council (HUDCC) and National Housing Authority (NHA). The Task Force is authorized to call on all DENR officials and employees for assistance in the execution of their assigned tasks.

The survey teams shall submit a weekly accomplishment report starting July 15, 2003 to Undersecretary Gerochi who in turn shall submit regular report to the Secretary.

The focal person for technical component shall be the overall coordinator of the survey teams. The Management and Information System Division of DENR-OSEC shall provide the cartographic services for Team from Region III and NCR while Region IV-A and IV-B shall provide all cartographic services for their respective teams.


The Teams shall be authorized to claim overtime pay not to exceed sixty (60) hours or reasonable traveling expenses, subject to the usual accounting and auditing rules and regulations.

All survey team members shall report to their respective mother units upon completion of their assigned tasks.

The DENR-NCR is hereby authorized to create the Task Force Secretariat as chaired by RTD Barcelo.

All expenses incurred in the conduct of these activities shall be charged against the special fund for the purpose which shall be downloaded to the DENR-NCR subject to the usual accounting and auditing rules and regulations.

This Order shall take effect immediately and shall remain in force until the submission of terminal report to the Secretary.
