CREATION OF A MULTISECTORAL TEAM TO CONDUCT **EVALUATION AND REVIEW OF INDUSTRIAL FOREST MANAGEMENT AGREEMENTS** (IFMAs) **AND** SOCIALIZED INDUSTRIAL FOREST MANAGEMENT AGREEMENTS (SIFMAS) ISSUED IN GENERAL NAKAR,

INFANTA AND REAL, QUEZON

The Team is tasked to do the following:

- 1. Coordinate with the RED, RTD, PENRO, CENRO, LGUs and other concerned group in the conduct of the review and evaluation of IFMAs and SIFMAs;
- 2. Review and assess the procedures/processes in the issuance of IFMAs and SIFMAs;
- 3. Evaluate the issues and concerns raised on the issuance of IFMAs and SIFMAs in the areas;
- 4. Finalize the MOA between DENR and Multi-Sectoral Watershed Management Council (MSWMC) for the management of Infanta-Real Watershed; and
- 5. Conduct study on the establishment of watershed in General Nakar, Quezon from Barangay Mahabang Lalim to San Marcelino or Agos River.
- 6. Submit report on findings and recommendations ten (10) days after the conduct of the assigned tasks.

All travelling expenses and other incidental expenses to be incurred during the conduct of the activities shall be charged against their respective offices subject to the usual accounting and auditing rules and regulations.

This Order takes effect immediately.
