Participants are requested to bring the following as their working document in the workshop:

- a) Copies of quarterly BMS data i.e. minutes and data sheets from FGD, photos from photo documentation method, transect field data sheets, and field diary. As much as possible the data should have been organized and analyzed in accordance with the BMS manual:
- b) Topo maps showing vegetation and location of BMS sites;
- c) List of key species and resource and land uses being monitored; and
- d) Documentation on actions taken by the PAMB, PASu or the LGU as a result of BMS. This may include PAMB resolutions, municipal/barangay ordinances, among others.

Actual transportation costs, accommodation and food during the two (2) day workshop shall be shouldered by the Nordic Agency for Development and Ecology (NORDECO). Other incidental expenses of the participants shall be charged against their respective offices subject to the usual accounting and auditing rules and regulations.
