In the interest of the service, a Fact-Finding Team is hereby formed to gather substantial information/*prima facie* evidences on the complaints against concerned personnel of DENR Region No. 8, Tacloban City and other related cases threat to be used as basis in decision making. 1. RE: request of PENRO Rodolfo M. Jaca, Ceso V for formal investigation against Forester Cesar L. Bartolome, Leopoldo D. Baldoz, Aleen S. Cebuano, Engr. Danilo Chavez, Survey Aide Norberto Rozel, Jr. Engr. Aide Lebrado Bolaba, Chief Land Classification Party, Solomon D. Covita and OIC, RTD Felipe S. Calub for alleged Misrepresentation of facts, Incompetence, Dishonestly and Acts Inimical and Detrimental to the best interest of Public Service.
2. RE: request of PENRO Edgardo O. Galeon for administrative sanctions against PENRO Danilo A. Javier, Forest Ranger Remelio A. Javier and

3. RE: unauthorized release of ONE (1) Unit Truck Bearing Plate No. GNE-690 owned and operated by Mrs. Delia Escoto, Lorente, Eastern Samar.
4. RE: CENRO vehicle of Catbalogan, Samar which was arbitrarily apprehended by PNP elements at San Juanico Bridge, Tacloban City last July 26, 2003.


The Team is authorized to seek the assistance of any DENR personnel and/or other parties who may be able to shed light on the aforementioned complaints against DENR officials/employees.

The Regional Executive Director, DENR Region No. 8, Tacloban City shall provide the necessary assistance/facilities to the team in the accomplishment of its task.

A comprehensive report on the subject matters shall be submitted to the undersigned through the Undersecretary for Field Operations fifteen (15) days after completion of the fieldwork.

All expenses incurred shall be charged against the funds of the Office of the Secretary subject to existing accounting and auditing rules and regulations.

This Order shall take effect immediately.
