**SUBJECT : AUTHORIZING DENR PERSONNEL TO PARTICIPATE
IN THE LAUNCHING OF SMOKE FREE EDSA CAMPAIGN
ON 27 SEPTEMBER 2003**

The Department of Environment and Natural Resources will launch on 27 September 2003 the "Smoke-Free EDSA" in cooperation with the Department of Land Transportation and Communications (DOTC), Land Transportation Office (LTO), City governments of Quezon City, Makati City, Mandaluyong, and Pasay; Bantay Kalikasan, Partnership for Clean Air and other enforcement Groups.

The "Smoke-Free EDSA" campaign aims to improve the air quality in Metro Manila's primary and historic thoroughfare, targeting a twenty percent (20%) reduction of the total Suspended Particulate (TSP) in EDSA by end of 2003.

The launching will be held at the People Power Monument along EDSA at 9:00 a.m.. The activity will start at 7:00 a.m. with a motorcade of vehicles using "clean Fuel" such as bio-diesel, and LPG among others. A Mass will follow the motorcade at 8:00 a.m..


