**SUBJECT : ABOLITION OF THE PATENT REVIEW COMMITTEE
CREATED PURSUANT TO SPECIAL ORDER NOS.
2001-491, 2001-556 AND 2002-211, AND CONSTITUTING
A POOL OF LAND PATENT REVIEWERS ON AN ON-
CALL BASIS**

In view of the issuance of Department Administrative Order No. 2002-20 dated 04 October 2002 giving the regional offices the authority to sign and approve land patents not exceeding three (3) hectares, the Patent Review Committee created pursuant to Special Order Nos. 2001-491 dated September 7, 2001, 2001-556 dated September 28, 2001 and 2002-211 dated March 13, 2002 is hereby abolished. A pool of reviewers, who shall report to the DENR-CARP National Secretariat on an on-call basis, is hereby constituted to review land patents and other land conveyances/instruments submitted for the Secretary's approval.


