**SUBJECT : Reporting and Entitlement of Personnel Detailed to the Land Administration and Management Project (LAMP) (including Amendment of Special Order No. 2002-1017 dated November 29, 2002 and Special Order No. 2001-44)**

In the interest of the service, Special Order No. 2002-1017 dated November 29, 2002 is hereby amended due to the replacement by the Land Registration Authority, a co-implementer of LAMP, of the Prototype Manager for LRA-managed LAMP Prototype Implementation Office 2 (PIO 2). Moreover, consistent with the agreement of the LAMP Inter-Agency Coordinating Committee (now the LAMP Task Force) to utilize existing staff of key implementing agencies and in aid of strengthening the LAMP Project Management Office (PMO), Special Order No. 2001-44 dated January 22, 2001 is hereby amended to change the Monitoring and Evaluation Unit Chief. The designation of Support Services Unit Chief is likewise authorized.


With the foregoing, the following changes are hereby authorized:

The Prototype Manager shall report to PIO 2 office located at the 2<sup>nd</sup> floor, LRA Building, East Avenue, Diliman, Quezon City. The two (2) PMO personnel shall clear themselves of all present work responsibilities and assume their new designation.

In their new assignment, they shall be entitled to claim expenses and other allowances/benefits attached to their new designations, including Representation and Traveling Allowance for the Prototype Manager and Unit Chiefs, chargeable against LAMP funds subject to existing auditing and accounting rules and regulations.

This Order shall take effect immediately and supersedes all previous issuances inconsistent herewith.
