

The herein designated Regional and PENRO IP Desk Officers shall discharge the following duties and functions:

1. To serve as the focal office on matters pertaining to the concerns IPs/ICCs vis-à-vis ENR laws, programs, and projects;
2. To ensure that appropriate information and education activities on the IPRA, in close coordination with the NCIP, are implemented within the DENR Office concerned and its partner sectors;
3. To coordinate closely with their NCIP counterparts for institutionalization of DENR-NCIP harmonization efforts;
4. To identify and recommend with their NCIP counterparts, officers/members of Indigenous Peoples organizations as Deputized Environment and Natural Resources Officers (DENROs) in accordance with existing rules and regulations;
5. To provide technical assistance to IPs/ICCs in the preparation of their Ancestral Domain Sustainable Development Plan and Protection Plans (ADSDPP) in coordination with NCIP; and
6. To implement other relevant activities deemed urgent by higher authorities.

The designated Regional and PENRO IP Desk Officers shall be under the direct supervision of the Regional Executive Director/PENRO. They are hereby authorized to avail of the services of any employee of this Department and/or any of the bureaus and offices in the discharge of their official functions.

This Order takes effect immediately and shall remain valid unless revoked. All previous orders, circulars, and guidelines inconsistent herewith are deemed revised, amended, and revoked accordingly.
