Likewise, in order to ensure effective and efficient implementation of the FSP the designated Regional Focal Person is also included in the S.O. The Focal Person shall report to the Unit/Division currently responsible in the implementation of FSP in their respective Regions on a full-time basis and handle only FSP related activities.

Upon receipt of this order, all newly assigned personnel under this Order shall clear themselves of all work, financial and property accountabilities from their present place of assignment and immediately report to units/places where they are assigned. On the other hand, all SUSIMO staffs who are covered by the previous Special Orders and are not included in this Order shall also clear themselves of all work, financial and property accountabilities and shall report to their mother units. The Regional Executive Director shall ensure compliance to this Order and shall inform NFDO for reference purposes.

This Order takes effect immediately and supersedes, modifies, or amends previous orders, memoranda or instructions inconsistent herewith.
