**SUBJECT : DEPLOYING CERTAIN PERSONNEL TO CONDUCT OCULAR INVESTIGATION AND APPRAISAL FOR THE CREATION AND ESTABLISHMENT OF PROJECT MANAGEMENT OFFICE (PMO) AS THE IMPLEMENTING ARM OF THE LAKE LANAO WATERSHED PROTECTION AND DEVELOPMENT COUNCIL (LLWPDC) IN THE LAKE LANAO WATERSHED AREAS**

In the interest of service and in pursuance with the LLWPDC Resolution No. 2003-02, dated 5 December 2003, Series of 2003, the following personnel are hereby deployed in the Provinces of Lanao del Sur and Lanao del Norte to conduct ocular investigation and appraisal in order to ensure systematic, smooth and harmonious establishment of the PMO, viz;

1. Datu Jubair L. Macaumbos – Consultant / Project Director  
PMO – LLWPDC
2. Siram A. Pagsidan – Special Investigator 11  
Office of the Assistant Secretary for Muslim Affairs
3. Mama D. Atar – Survey Aide I  
PMO, LLWPDC, Marawi City

As such, the following shall be performed by the above-named personnel:

1. Hold conference with the members of the LLWPDC, the TWG, all LGUs in Lanao del Sur, Lanao del Norte, and the cities of Marawi and Iligan, the PNP and AFP, POs, NGOs and other civil society groups, the academe and religious leaders and solicit their comments, ideas and/or recommendation regarding the establishment of the PMO;
2. Coordinate with the Secretariat of the LLWPDC for the preparation of the PMO Manual of operations and staffing pattern; and
3. Submit a Comprehensive Report, reflecting among other things, the general perception of the public and the local leaders of both in government and private sector, and other related information for the establishment of said PMO. Within sixty (60) days from the date of signing of this Order; appropriate staffing pattern and Operations Manual of the PMO consistent with the aforementioned LLWPDC resolution.

4. Perform other related works requisite and necessary in coming up with most appropriate and systematic mechanics and strategies in the establishment of the PMO.


In addition the above-named personnel shall likewise perform the following intervening works in order to complement the DENR and the LLWPDC existing administrative mechanism in pursuit of the protection and development of the Lake Lanao Watershed areas and its environs:

1. Intensify current programs/projects and activities for the protection of the Lake Lanao Watershed by coordinating with the concerned law enforcement agencies against illegal logging, timber poaching and illegal transport of lumber from Lanao del Sur to any point of destinations in the Philippines;
2. Coordinate the law enforcement protection and development programs with various government law enforcement agencies, such as the Philippine Marine Corps in Lanao del Sur, National Bureau of Investigation, National Intelligence and Coordinating Agency, Philippine National Police and Local Government Units under the Task Force Lake Lanao;

In this connection, the above-named personnel are hereby authorized to hold temporary office in any DENR Regional, Provincial and City Offices. All Officials and personnel thereto are hereby directed to extend necessary support and assistance to the above-named officials in the discharge of their officials works, when every necessary.

The subject personnel are hereby authorized to charge their reasonable transportation fares, pier diems, allowances and other traveling expenses, subject to usual accounting, budgeting and auditing rules and regulation.

This travel shall take effect upon signing and/or approval thereof, and shall be automatically expired sixty (60) days from date of approval.
