SUBJECT: AUTHORIZING THE ATTENDANCE AND PARTICIPATION OF SOME DENR OFFICIALS/PERSONNEL IN THE DENR-CARP MID-YEAR ASSESSMENT AND REPROGRAMMING WORKSHOP ON 03-05 JUNE 2004 AT TAGAYTAY CITY

In the interest of the service and in order to sustain the Department's momentum in accomplishing its activities/targets under the Comprehensive Agrarian Reform Program as well as SONA commitment, the conduct of a Workshop on the above subject is hereby authorized on June 3-5, 2004 at Tagaytay City. The Workshop aims to:

- I. assess the Department's accomplishment for the period of January – April 2004 on the distribution of 50, 000 hectares of public A&D lands under the President's SONA commitment vis-à-vis financial utilization;
- II. reprogram and firm-up the Department's targets under PLS and PPI from May – December 2004; and
- III. assess the Department's accomplishment under the Survey and Land Titling component of the DAR-ADB-ARC Projects in lieu of its termination on June 2004.

A. Central Office



Traveling expenses of the Central Office participants and all other expenses to be incurred for the assessment/workshop shall be charged against OSEC SONA Fund 101 and OSEC transferred funds under OSEC-ARCP Fund 102. No registration fee shall be charged from the regional participants. However, their traveling expenses shall be charged against their respective regional allocation under ARF 158 budget, subject to the existing accounting and auditing rules and regulations.
