**SPECIAL ORDER NO.** 481

**SUBJECT : AUTHORIZING THE DENR AND EMB REGIONAL SOLID WASTE MANAGEMENT OFFICERS TO PARTICIPATE IN THE BARANGAY CONFERENCES IN LUZON, VISAYAS AND MINDANAO**

In the interest of the service and in order to encourage public and private partnership in the implementation of Republic Act No. 9003, **two (2) Solid Waste Management Officers** (one from DENR & one from EMB) from each Region are hereby instructed to participate in the Barangay Conferences titled **Replicating the PaLiSam Cluster-MRF Project in July 2004**. The purpose of these activities is to promote and present the implementation experience of the PaLiSam Community MRF, Inc. in Calamba City, Laguna.

The conferences shall be participated by local government units, DENR and EMB Regional Offices and the private sectors.

Furthermore, the SWM Coordinators in Regions 10, 7 and Cordillera Administrative Regions, being the host regions, are likewise instructed to do the tasks listed below:

**Region X DENR and EMB SWM Coordinators**

- Identify and invite fifteen (15) barangay officials in cities/municipalities adjacent to Cagayan de Oro City to participate in the Mindanao Barangay Conference which will be held on July 14, 2004.

**Region VII DENR and EMB SWM Coordinators**


- Coordinate with DENR-CENRO in Cebu City and the local government of Cebu City in identifying and inviting thirty-three (33) participants in the Visayas Barangay Conference which will be held on July 21, 2004.
  - 23 of the 33 participants should come from the local government of Cebu City and the private sectors in the area.
  - 10 of the 33 participants should come from barangays within and adjacent to Cebu City.
- Request the local government of Cebu City to take active part in the Opening Program particularly in delivering the **Opening Prayer, National Anthem and Welcome Remarks.**

**CAR DENR and EMB SWM Coordinators**

- Identify and invite twenty (20) barangays officials in cities/municipalities adjacent to Baguio City to participate in the Luzon Barangay Conference which will be held on July 28, 2004.

The venue for the training as well as food for the participants will be shouldered by Public and Private Partnership in Urban Environment-Solid Waste Management Project of the Office of the Secretariat of the NSWMC. **While their travel expenses as well as the accommodation of the Regional SWM Coordinators shall be charged against their respective offices subject to the usual accounting rules and regulations.**
