SUBJECT : **AUTHORIZING THE DENR AND EMB REGIONAL ECOLOGICAL SOLID WASTE MANAGEMENT COORDINATORS TO PARTICIPATE IN THE MULTI-SECTORAL CONSULTATION ON THE NATIONAL SOLID WASTE MANAGEMENT FRAMEWORK IN LUZON, VISAYAS AND MINDANAO**

In the interest of the service and in order to facilitate the finalization of the National Solid Waste Management Framework, **two (2) Ecological Solid Waste Management (ESWM) Coordinators** (one from DENR & one from EMB) **from each Region** are hereby instructed to participate in the "Multi-sectoral Consultation on the National Solid Waste Management Framework" in July 2004.

The schedule of the activities is as follows:

Multi-sectoral Consultation on the NSWMF in South Luzon	NCR, 4A, 4B, 5	August 5, 2004	Air Quality Management Training Center DENR Cmpd., Visayas Ave., Quezon City	15 from each region

Furthermore, the ESWM Coordinators are instructed to **identify and invite the participants** coming from the **LGUs, NGOs, Industry and Academe** within their respective regions. Likewise, the host regions (Region 10, 7, CAR and NCR) are requested to take active part in the Opening Program particularly in delivering the **Opening Prayer, National Anthem, Welcome Remarks and Introduction of Participants.**

The cost of the venue and food for the participants in the Multi-sectoral Consultations in **South Luzon, Visayas** and **Mindanao** will be shouldered by the UNDP-Public and Private Sectors Convergence for Solid Waste Co-governance in Urban Poor Communities (PPPUE-SWM) Project of the Office of the Secretariat of the NSWMC. While the cost of the venue and food for the participants in the **North Luzon** Multi-sectoral Consultation shall be charged against the funds of the Environmental Management Bureau Central Office.

On the otherhand, the **travel expenses** as well as the **accommodation of the participants** shall be charged against the **funds of their respective offices** subject to the usual accounting rules and regulations.

This Order shall take effect immediately.
