- 4. Review and approve project proposals and other statistical activities particularly for the yearly celebration of the National Statistics Month (NSM) and budgetary requirements under Statistical Services; and
- 5. Recommend disciplinary actions on non-compiling Regions in support to the implementation of the DENR Statistical Reporting System (SRS) and other statistical requirements.

## The Technical Committee has the following functions:

- Coordinate the statistical requirements and concerns with the National Statistical Coordination Board (NSCB);
- 2. Prepare the yearly integrated DENR statistical plans, programs and budget for submission to NSCB and DBM;
- 3. Monitor and assess the implementation of the DENR Statistical Reporting System (SRS);
- Prepare training proposals in line with the Statistical Manpower Development and coordinate training implementation and GADrelated project proposals;
- Review the designated statistics of the Bureaus for submission to NSCB:
- 6. Provide technical and other support services that the Executive Committee may require in the execution of its functions;
- 7. Facilitate the conduct of Executive Committee meetings including the preparation of agenda and documentation;
- 8. Coordinate and participate in the yearly celebration of the National Statistics Month (NSM); and ensure participation to the National Convention Statistics; and

9. Recommend and monitor posting of relevant statistics in the DENR website.

The Chairman of the Executive Committee shall act as Board Member in the National Statistical Coordination Board. The Chief of the Research and Statistics Division, Planning and Policy Service shall act as the Chairman of the Technical Committee on Statistical Concerns and Coordination.

The Research and Statistics Division of the Planning and Policy Service shall act as the Secretariat to both the Executive and Technical Committee on Statistical Concerns and Coordination in addition to its regular functions.

Any expenses to be incurred in connection with this order shall be chargeable against their respective/offices subject to the usual accounting and auditing rules and regulations.

This Order supersedes all other orders relative thereto and shall take effect immediately and continue to remain in force until revoked or amended in writing.
