DEPUTIZING MAJ. GEN. PEDRO R. CABUAY, JR. AFP, COMMANDING GENERAL, 2ND INFANTRY (JUNGLE FIGHTER) DIVISION, PA, CAMP MATEO CAPINPIN, TANAY, RIZAL AS ENVIRONMENT AND NATURAL RESOURCES OFFICER COVERING THE TERRITORIAL JURISDICTION OF 2ND

**INFANTRY DIVISION, PA** 

Pursuant to the pertinent provisions of existing environment and natural resources laws and regulations, specifically DEN\_R Administrative Order No. 41, S. 1991, and in order to directly involve the AFP-PA 2nd Infantry (Jungle Fighter) Division based at Camp Mateo Capinpin, Tanay, Rizal, in the protection and conservation of the country's environment and natural resources, Maj. Gen. PEDRO R. CABUAY, JR., AFP Commanding General of 2nd Infantry Division, PA, is hereby deputized as DEPUTY ENVIRONMENT AND NATURAL RESOURCES OFFICER (DENRO).

By virtue of this deputation, he is authorized to detect and investigate violations of natural resources laws, rules and regulations and, in the absence of an authorized DENR personnel arrest even without warrant any person who has committed, is committing or is about to commit in his presence any of the criminal offenses defined under the said laws.

In all instances of detection, arrest and/or seizure, he shall deliver within the period prescribed by law from the time of arrest and seizure of the offender including the confiscated natural resources products, tools/equipment and conveyances to, and file the proper complaint with the appropriate official designated by law to conduct preliminary investigation and file information in Court through the CENRO/PENRO/RED concerned, whoever is most expeditiously available.

He shall also act as witness in Court for the speedy prosecution of criminal complaints against environmental and natural resources law violators.

Moreover, he shall assist in the enforcement of laws, rules and regulations, and in the conduct of environmental and natural resources information and education campaign such as public meetings/assemblies and other extension activities of the DENR within the territorial jurisdiction of 2nd Infantry Division, PA in coordination with the officials/personnel and/or private agencies involved in similar work.

He shall submit monthly accomplishment report to the DENR using the standard reporting form provided under DENR Administrative Order No. 41. S. 1991.

This deputation authorizes him only to exercise the power and authority conferred herein within the territorial jurisdiction of his command and is not transferable. Moreover, and in furtherance to this deputation, Gen. Cabuay, Jr. may issue instructions to his subordinate officers of the 2nd Infantry Division, PA only to assist him in the exercise of the power and authority conferred on him.

This Deputation Order takes effect immediately and will expire on or unless revoked or terminated by this Office.
