Subject: Reorganization of the Philippine Eagle Working Group (PEWG)

In the interest of the service and in order to effectively and efficiently carry out the government's conservation program on the critically endangered Philippine Eagle and other birds of prey, the Philippine Eagle Working Group (PEWG) created under DENR Special Order No. 1333, Series of 1994 is hereby reorganized structurally and functionally, to be composed of the following:

The Committee shall have the following functions:

1. Conduct periodic review of the Integrated Plan (IP) for the Conservation of the Philippine Eagle;

2. Exert maximum efforts to implement the Plan nationwide, through the PAWB-Philippine Raptors Conservation Program and PEF-managed Philippine Conservation Program in Mindanao;
3. Provide direction, technical assistance and other forms of support in the implementation of the Plan;
4. Formulate, in coordination with all concerned parties, policies, rules and regulations pertaining to the conservation of the Philippine Eagle and other birds of prey;
5. Provide support to PAWB in the annual celebration of the Philippine Eagle Week, especially in identifying activities to be carried out during the said celebration, among others;
6. Provide guidance to various national government agencies, local government units, non-government organizations and other entities regarding the conservation of the Philippine Eagle and other birds of prey, as necessary;
7. Submit report, including recommendations, to the Secretary, DENR through PAWB pertaining to the implementation of the Plan.

The PEWG shall be supported by a Secretariat composed of the following:

The Secretariat shall, among other responsibilities, provide administrative support, undertake liaison work for the PEWG, send notices and record the minutes/proceedings of the PEWG meetings.

The members of the PEWG and Secretariat are entitled to claim reasonable traveling allowances and other expenses that may be incurred in the performance of its tasks, chargeable against the PAWB-PRCP funds, subject to availability of funds and to usual accounting and auditing rules and regulations.

This Order takes effect immediately and revokes DENR S.O. No. 1333, Series of 1994 and other orders, circulars, or memoranda inconsistent herewith.
